Accrediting Team Comin To Tampa U. March

Alumni to Honor Spartan Athletes

A Lettermen's Banquet will be staged Feb. 20 at the Crystal Ball Restaurant, under the sponsorship of the newlyactivated Alumni Athletic Committee, in honor of the football and basketball teams of the University.

The banquet will also serve as the "kick-off" meeting of the Alumni concerning its campaign to raise \$16,000 to help defray the cost of fielding a first rate small college football team next season, according to Bill Fisher, General Chairman of the Alumni campaign.

Letters will be presented to members of the Spartan grid team by Coach Mike Gaddis. Though the cagers will be honored guests, their letters will be awarded at a later date, upon the conclusion of the basketball season.

Principal speakers at the Banquet, which is scheduled to be an annual affair and which will get underway at 8 o'clock, include Dr. Nance, who will make the opening address, Pete Norton, sports editor of the Tampa Tribune, Clair Pittman, president of the Alumni Association, Mike Gaddis, and Sol Fleischmann, popular sports announcer for Times Radio Station WDAE who will serve as master of ceremonies.

The Alumni Athletic Committee has been divided into four teams for the purpose of the campaign and is under the direction of Bill Fisher, chairman of the drive. Team Captains include Fisher, Rudy Rodriguez, Dr. Paul Mc-Closkey and Crockett Farnell.

Any member of the Alumni or friend of the University interested in attending the banquet should contact Fisher at 1921 Gray St., Tampa, or at H-1194 or H 10-845. Reservations, at \$2.25 per plate, will close Feb. 17.

A number of distinguished guests will be invited to the Banquet as guests of the Athletic Committee.

*sents a great step forward in the institution's long fight to obtain accreditation. Before any college or university can merit a special study inspection by an Association committee, it first must convince the group that it is in a position to deserve accreditation. After four years of intensive preparation, dating back to shortly after the end of the war, the University was informed last December that an inspection team would visit the institution this year.

In keeping with the University's effort to meet all accreditation requirements. it has limited the enrollment for the Spring semester this year to 1000 fulltime students. The institution now provides one full-time instructor for each 20 students, as required by the accrediting Association.

In addition, every effort will be made. according to Dr. Nance, to meet the University's Endowment Fund goal of \$500,000 by the time the committee arrives on the campus.


Six new members — three of whom have doctor's degrees — were officially welcomed to the University of Tampa instructional staff February 1.
