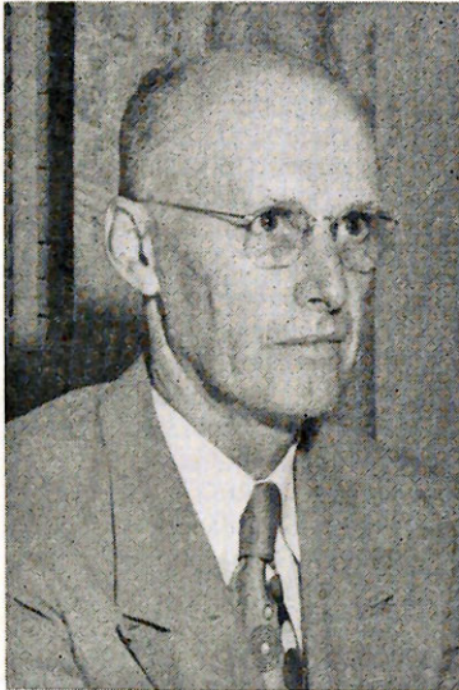

**Dean M. C. Rhodes**

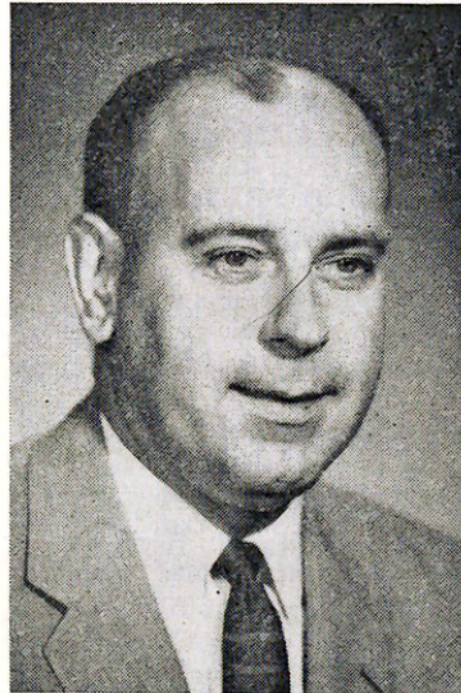

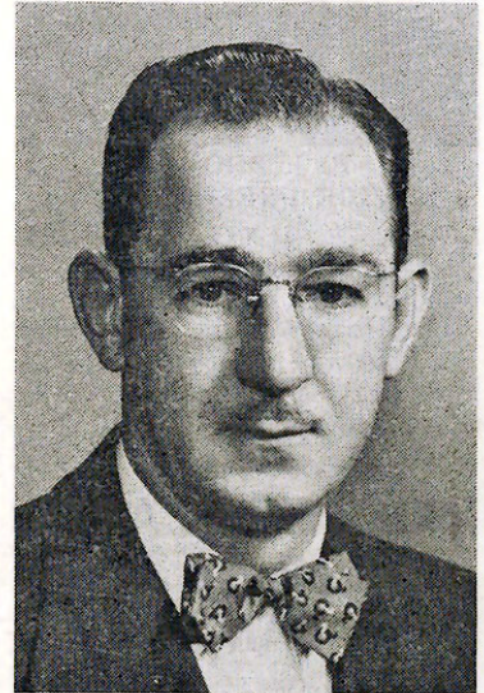

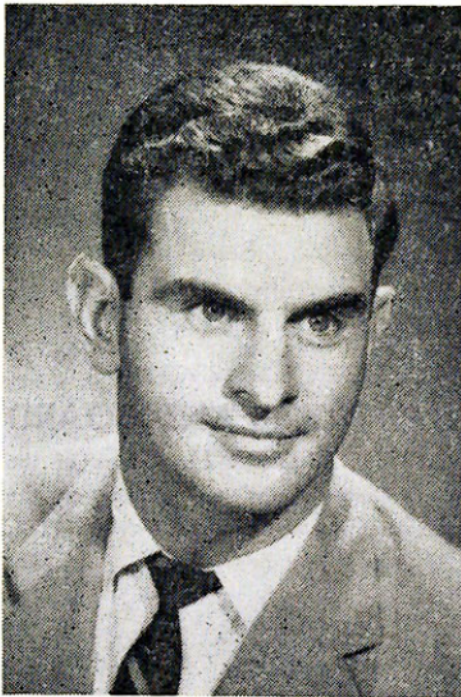
constructive thoughts on my behalf, I look to the future hopefully and gratefully.

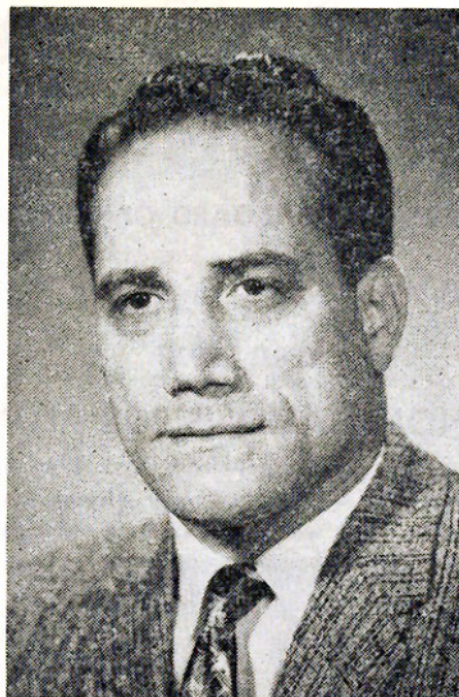

In the address to be given at West Palm Beach, Professor Heiser reviews the developmental stages of the National Secretaries Association, as well as statistics on what has happened to candidates who took the Examination since it was first given. The CPS Examination has for its professional purpose to distinguish well-trained and competent secretaries. The Examination comprises Accounting, Business Law, Economics, various areas in Business Administration, Human Relations. It is a two-day examination. Those who pass the examination receive a Certification as C.P.S. from national headquarters of the National Secretaries Association.

## FACULTY NOTES

Miller K. Adams of our athletic department is currently chairman of the Florida Association of Health, Physical Education, and Recreation's Committee on Constitution and By-Laws. He is also serving as Director for the State of Florida publications for the American Association for Health, Physical Education and Recreation.

Although teaching at the University this summer, Mr. Adams will continue gathering material and compiling his doctor's thesis.

Mr. Adams is doing his doctoral study at NYU and will spend about 3 weeks in New York after his summer teaching is completed.

In November of last year Dr. J. Ryan Beiser was elected to the State Board of Directors of the Florida Citizenship Clearing House and will attend their board meeting in Tallahassee on April 15th. Dr. Beiser was also appointed as State Chairman of the Membership Committee of the Florida Historical Society last March.

The Department of History and Political Science is also working on a number of research projects. These are: a textbook being written by Dr. Beiser and Dr. Stephen L. Speronis titled "Russia: An Institutional and Cultural Appraisal." Dr. Speronis has recently written several articles for the Florida Historical Society. "The Origin and Background of the Greek Colony of Tarpon Springs" will be done in three parts from the beginning in Ancient Greece to the present time. His other articles are "Capodistrias and Russia" and "The Rougabe Papers".

Dr. Jesse Keene delivered a paper at the annual meeting of the Florida Historical Association in Miami on Garino Gutierrez and his contributions to the cigar industries of Tampa. He was also elected as one of the vice presidents of the Southern Intercollegiate Athletic Association at their meeting last December.

tion in the drafting departments of some of the largest manufacturing concerns of the world. Henry, like many industrial arts graduates, also had a major in math and physics. Then there is Clem Omichinski of last year's graduating class who went into a very profitable civil service position. Richard Reece, also of last year's graduating class, found more profitable employment in Boy Scout work right here in Tampa. Mr. Reece and Mr. Walston both received their Masters degrees at the University of Florida last summer. Paul Gatta, one of our first industrial arts students, took graduate work at the University of Florida and is now a prosperous local building contractor.

## CLYDE T. REED

Mr. Reed, Head of the Department of Biology has been actively promoting the cause of Science Education at the state and national levels. He was one of three scientists selected to go to Oak Ridge to collaborate with representatives of the American Association for the Advancement of Science, the Academy Conference and the National Science Foundation in planning a conference of national scope on Junior Academy Science programs and other programs designed to increase Scientific Manpower in America and to improve science education. Mr. Reed served as chairman of the section or organization at this conference held in Chicago in February.

Earlier in the year Mr. Reed was chairman of the Program Committee and the Local Arrangements Committee for the Annual meeting of Florida Academy of Science. Mr. Reed, past president of the Biological Section of the Florida Academy of Sciences, is a member of the Council of that organization and Chairman of the Coordinating Committee of the Academy for the Junior Academy Division.

Currently Mr. Reed is working on a proposal and request to the National Science Foundation for financial support of a program on in-service education and training for science teachers in the Public Schools, to be conducted at the University of Tampa.

### DID YOU KNOW THAT . . .

The University of Wisconsin newspaper had this to say about their trip to Tampa. "Tampa University with possibly the best rowing water of any school in the country boated a powerful crew. Physically, Tampa has it, and with more experience may be rough to handle in the Dad Vail this Spring. We managed to defeat Tampa by two feet in a ding-dong battle. The boats were never more than a length apart, the lead changed hands several times during the race. All in all, the Florida trip was a great success."

The first mascot of the "Spartans" was Doug Belden . . . He stowed away on the bus on the first away trip to Gainesville.

The first touchdown for the University of Tampa Spartans was scored by Fireman Jimmy White. It was against Bowden College. . . . Incidentally, his boy at Hillsborough High School is one of the best baseball prospects in the area.

Personable Marcelino Huerta, Jr. is the sixth Head Football Coach and Athletic Director here on the banks of the Ole Hillsborough . . . When he took over he was the youngest Athletic Director and Head Football Coach in the Country.

Earl Hatcher, principal at Madison Jr. High School, scored the first touchdown across the West goal at Phillips Field . . . Eddie O'Reilly, Southern Truck Lines exec, scored the first touchdown across the East goal.

The first crew ever beaten by the Spartan oarsmen was Dartmouth College in 1948 . . . Coach Bill Stalnaker was a member of this jolly crew, by golly.

Vince Chico is probably the only football player in the country who was tackled from the sidelines by a trigger happy visitor two times in two successive weeks. Yes Sir, Rose remembers that.

Coach Nash Higgins originated the nickname of the University of Tampa athletes as "Spartans" . . . He established the school colors, Red, Black and Gold . . . He organized the first formal Intercollegiate football team here at the University, and in its first year the "Spartans" won 6, tied 2, and lost 2 . . . The first basketball squad

was organized under Coach Higgins' direction and in its first year won 28 of the 32 games played. (Dig that, Gene?) . . . As a matter of fact, to the uninitiated, our friend is Dr. Nash Higgins. Coach Higgins had an honorary Doctor of Humanities Degree conferred upon him in 1949 by Dr. E. C. Nance.

To the best of everyone's knowledge the only three brother lettermen from one University are Dr. John, Bill and Pug Read.

The Spartan basketball cagers hold the record for the highest number of points scored by any team in the new George B. Howell Gymnasium . . . 117 points.

The first away game ever played by the Spartan gridders was at La Grange, Georgia with Bowden College . . . Certainly, we won!

The first time Champ Williams and Mike Whitwell ever carried the ball for the Spartans they went all the way for a touchdown.

Sam Bailey, competent assistant to Coach Huerta, was born off the coast of the United States . . . Sanibel Island . . . Ole Sanibel Sam!

President Eisenhower's golf pro at Gettysburg is Dick Schleichter, Spartan end, class of 1940 . . . By the way, Dick's wife is Director of Phys. Ed. at Gettysburg . . .

Ken Hance is a four-striper in the Navy . . . and Willie Godwin, who, in Nash Higgins' book, is the most versatile football player produced by the University of Tampa, is a Naval executive officer stationed in Casablanca.

Al Yorkunas, Yorkunas Advertising Agency; Ozzie Beynon, Inspector of Detectives; Dr. John Read; Dr. Ed Carter; Crockett Farnell, Superintendent of County Schools; Paul Straub, Athletic Director at Jesuit High School; Bill Minahin, member of the coaching staff at Plant High School; Ted Greene, member of the coaching staff at Jefferson High School; Ken Nuznoff, member of the coaching staff at Chamberlain High School are a few who arrived in Tampa from the hinterlands via the Spartan Scholarship Route, and elected to adopt Tampa as their home.

All the points scored against Stetson in 1951 were by Holland Aplin, Head Coach at Brewster Tech High School.

The first elected captain of the

Spartan gridders was Howie Beynon, Supervising Principal in Frostproof, Florida.

At one time the University of Tampa band had a "fight song" which they played at every pep rally and football game . . . What happened? . . . Can any of our Alumni find a copy of it?

The George B. Howell Gymnasium, home court of the Spartan hoopsters, is the first new construction in twenty-six years.

Since 1952, under the aegis of Coach Huerta, the Spartan football win and loss percentage is 739. Prior to 1952 the win-loss percentage was under 50 per cent.

Howie Bernstein dramatically scored the first basket in the new George B. Howell Gymnasium . . . He also made "All State" this year.

The Spartan baseball nine played 28 games last year and compiled a record of 8 wins 3 losses . . . How's that again, Sam?

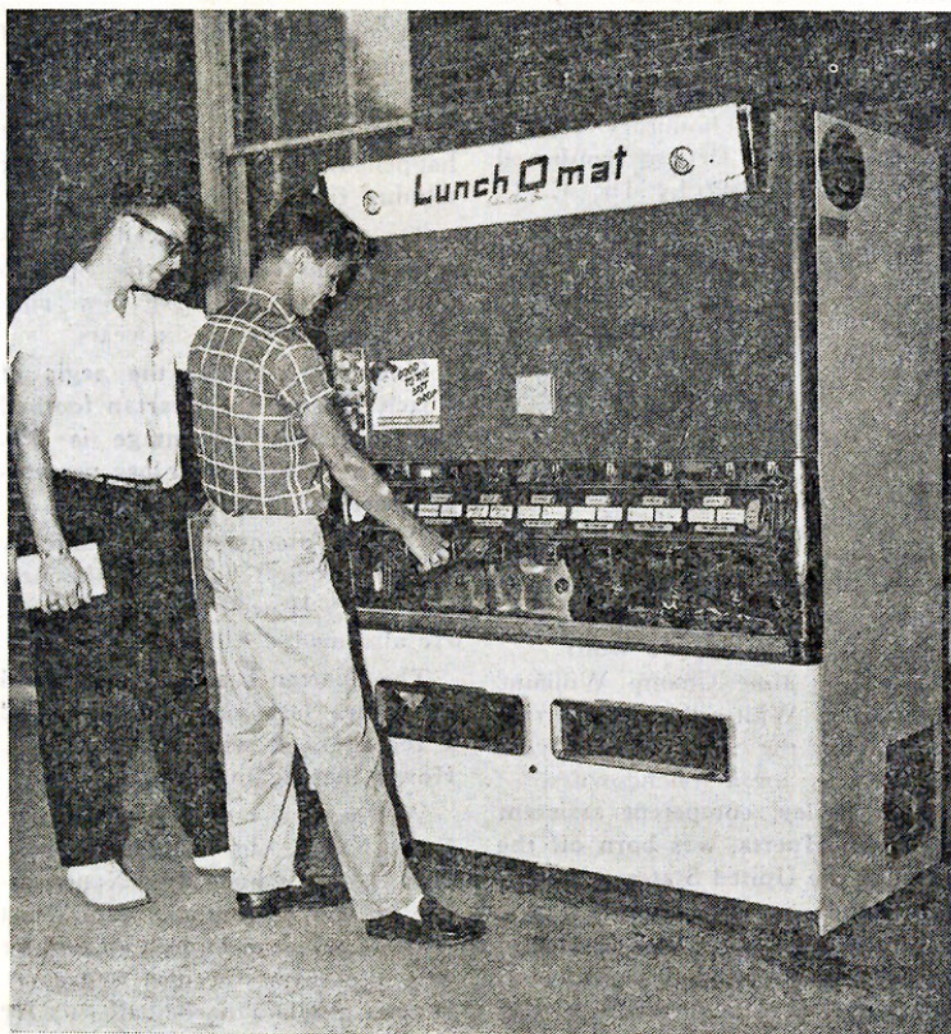
## UNIVERSITY OF TAMPA TECHNICAL SCHOOL IN CUBA
