Our name "The Muezzin" originated in the religion of Islam founded by the prophet Mohammed in the early centuries after Christ and practiced primarliy in middle eastern countries. The muezzin is the official who proclaims the azan (call to public worship) to which the Muslims respond with set phrases. The summoning is performed by the voice of the muezzin as he stands at the door or at the side of a small mosque (temple) or in the minaret of a large one. Today the muezzin still sounds the call to worship, but in some modernized mosques his voice is placed upon electronic recordings which are amplified to echo the azan throughout the countryside. The University of Tampa "Muezzin" publication performs a similar function in that it broadcasts the call for higher education among its readers. The name was inspired by Plant Hall's 13 Moorish style minarets, gleaming above trees and buildings as a landmark of learning in the heart of the city of Tampa.



This issue of THE MUEZZIN marks the first University of Tampa published annual report to the many publics served by the University. Its purpose is to communicate the University's significant progress toward its "Landmark of Learning" goal.

Many dedicated people have given us the personal assistance, financial help, and encouragement so necessary and vital for our continued thrust toward our goals. All of us at the University are deeply indebted and thus hope that this brief report will help keep you up to date.

The academic year 1971-72 was filled with enthusiasm, dedication, and the extra effort required to make considerable progress in our Key Result Areas. The Key Result Area document is a "management by objective" document. The KRA's were identified by members of the staff, faculty, students, and trustees during June and July of 1971. Two hundred eighty-nine (289) key result areas were identified as problem areas or areas of new dimension in which progress toward solution or implementation were desired. At the end of the academic year, the KRA's were graded out at 90% wherein either substantial progress or completion of the objectives were recorded.

Some of the highlights of the 1971-72 KRA's include:

Fairgrounds Property — Completion of negotiations and acquisition of the additional 33 acres of land.

New Marine Biology Program — Finalized and

projected enrollment increases are most noteworthy in this area of study.

Academic Reorganization — Accomplished with the deletion of nineteen (19) departmental chairmen positions and the establishment of six divisional chairmen to replace them. The new divisions are: Economics and Business, Fine Arts, Education, Social Studies, Science and Mathematics and Humanities.

Administrative Reorganization — An effectiveness review resulted in the elimination of nineteen administrative and classified positions.


Upgrading of Facilities — This has been accomplished through gifts and greater internal emphasis on an attractive campus appearance.

Associations and organizations resulted in the establishment of the University of Tampa as the site for the following academic professional meetings: National Personnel Deans Association; Southeast Region, 1973; History Association, 1973; Kappa Kappa Psi National Convention, 1973; Financial Aids Association, summer 1972.

A **Faculty Handbook** — The first draft of a much needed faculty handbook has been completed.

The Minaret Society was established to recognize individuals for the levels of their financial support to the University. We are pleased to report that 61 members have given or pledged \$211,000 during the first month of the Society's existence.

The University of Tampa was accepted for membership in the National Collegiate Athletics Association in record time. This membership has greatly enhanced the University's intercollegiate athletic program.

The stability of the University's financial position has continued. The 1971-72 fiscal year was concluded with a small surplus. This is particularly gratifying since many colleges and universities have experienced deficits in recent years.

Approximately eighty per cent (80%) of the enrollment continues from non-Florida residents. The freshman class was represented by persons from all fifty states and fourteen foreign countries. It is anticipated that the student body will retain this same cosmopolitan mix.

The graduating class for both December and May totaled over seven hundred. Our students are averaging completion of their degree requirements in slightly more than three years. In addition, the military bootstrappers and transfer students remain in the student body only approximately two years since a portion of their college work has been completed at other universities and colleges.

The continuing education program gained considerably during the year. Several new conferences and seminars were added. This division makes it possible for the University to maintain better year-round space utilization while performing a most significant public service.

The University continues to move forward with

its cultural programs. The Hoffman String Quartet played its Tampa engagements in the Fletcher Lounge. Esther Glazer as an Artist in Residence assisted with music instruction and performances. Dr. Duane Locke became Poet in Residence and began publishing the University of Tampa Review Both Dr. Locke and Miss Glazer are known nationally and internationally for their respective talents.

Faculty publications reached a new high. During preparation for lectures and teaching assignments, our faculty produced some outstanding scholarly articles and books. Although the University of Tampa is primarily a teaching university, the publication interests of our professors is most praiseworthy.

Your University has reached new levels of accomplishments and academic prestige. It is particularly noteworthy that it is currently moving toward new goals at a time when many private colleges and universities face enrollment declines and financial obstacles which seem overwhelming.

Finally, a master plan is being developed which will encompass the academic, personnel, and physical facilities needs of the University over a long range period. This master plan will become the road map of your university as we approach the twenty-first century. Indeed, it will encompass our collective understanding of that which is necessary for distribution as a "Landmark of Learning".

ODK Is Here

Omicron Delta Kappa, oldest, most prestigious men's leadership fraternity in higher education, was chartered on the University of Tampa campus in May.

In a special ceremony in the Plant Hall Ballroom, 19 students and four faculty members were initiated into the University of Tampa Circle of ODK. Mayor Dick Greco was inducted as an honorary member.

During the meeting FSU law student Wayne Rubinas, first university student ever elected national president of ODK, presented the charter and addressed the new UT chapter.

Dr. B. D. Owens, president of the University of Tampa and a member of ODK, made the closing remarks.

Founded in 1914 at Washington and Lee University, ODK now has chapters in more than 130 colleges and universities throughout the nation. University of Tampa efforts to form a chapter began in 1969 with Dr. Charles West, vice president for student affairs. The efforts were enhanced with the arrival last August of Dr. Edward Ward as director of continuing education. Dr. Ward is the national administrative secretary for ODK.

Six Outstanding Educators

Six members of the University of Tampa faculty and administrative staff have been named Outstanding Educators of America for 1972.

Those honored are: Dr. James Covington, professor of history; Dr. Eustasio Fernandez, chairman of the Modern Languages Department; Charles Hyde, associate dean of faculties; Dr. Duane Locke, poet-in-residence; Dr. Edward Ward, director of continuing education, and Dr. Charles West, vice president for student affairs.

Recipients are featured in the annual national awards volume, which lists those honored for exceptional service, achievements and leadership in education.

Dr. Covington, senior historian of the National Aeronautics and Space Administration, is a widely known authority on the state of Florida, having published much on the region's history.

Dr. Fernandez joined the University in 1951. He has conducted study tours of Mexico during midwinter intersessions and a study tour of Germany last June.

A native of Missouri, Dean Hyde became part of the UT faculty in 1960 and served as associate professor of economics and business. In 1970 he received the University of Tampa Alumni Association Award as outstanding faculty member.

Dr. Duane Locke, an alumnus of the University, is one of the most widely published contemporary poets. He has been chosen to help coordinate the the poetry-in-our-schools program for elementary grades in the fall.

An attorney with background in student affairs and business management, Dr. Ward, assistant to the president, has been active in developing the University's Department of Continuing Education.

Dr. Charles West, former chairman of the Department of Philosophy, served two years as dean of students and last year was appointed vice president for student affairs.

Selection of Outstanding American Educators is based on an educator's talents in the classroom, his contributions to research and his administrative abilities.

First ROTC Scholarships

Four University of Tampa students were recipients of the first Army ROTC scholarships ever awarded at the University.

Col. Walter M. Turner, UT professor of military science, in announcing the awarding of the two-year full tuition scholarships said each is worth about \$6,000.

Recipients were William Ringler and David A. Jones of Tampa; John G. Walsh, Wilton, Conn., and Dennis K. Degamon, North Massupequa, New York.

Scholarships cover all tuition, fees, books and supplies. Each recipient also receives \$100 per month subsistance allowance.

The University had been allotted only two scholarships, but the Third Army review board awarded an additional two on the basis of the qualifications of UT applicants, Col. Turner said. Selections are based on character, motivation toward an Army career and academic and ROTC records.

It's Official

Following approval by the Tampa City Council, the Florida State Fairgrounds' 33.11-acre tract officially became part of the University of Tampa campus, May 30.

Action by the Council endorsed a property trade deeding 23.72 acres of UT-owned riverfront property between Phillips Field and I-4 to the city in exchange for the fair land.

Appraised at \$582,000, the fair property will swell the University campus to 48.11 acres. The present campus, minus the former urban renewal land now comprising the North Campus, totals 15 acres.

The University will take full occupancy of the grounds after the 1973 fair.

The New Administrative Structure

President B. D. Owens has announced the first major administrative restructuring in the University's 41-year history. The new system, a giant step toward the University's model management goal, includes six new major divisions encompassing the more than 20 existing departments.

Associate Dean of Faculty Charles Hyde said by appointing division chairmen to carry out the functions of departments the University can add 14 courses to the curriculum without the addition of faculty.

Hyde also noted, "With fewer administrators we expect greater efficiency in making curriculum changes and in being more responsive to needs of students and faculty.

Heading the new divisions are Dr. William W. Cyzewski, Economics and Business; Dr. Samuel Brick, Education; Wallace Green, Fine Arts; Dr. Francis Thompson, Humanties; Dr. Richard Gude, Mathematics and Science, and Dr. J. Ryan Beiser, Social Sciences.

New divisional breakdowns are Economics and Business: accounting, business and economics; Education: education, health, physical education, industrial arts and speech; Fine Arts: art, drama, and music; Humanities: English, modern language, philosophy.

The restructuring program comes under the purview of the vice president for academic affairs. The duties of that office had been administered by Hyde pending the August arrival of Dr. Michael Mendelsohn, who comes to the University from the U.S. Air Force Academy.

New Administrators

The University will add two key administrators this fall, a charter member of the Air Force Academy and a former professional baseball player.

Dr. Michael J. Mendelsohn became the University's new vice president for academic affairs and dean of faculties in August.

A specialist in modern drama and world literature, he has been professor of English and humanities at the Air Force Academy and supervises some 20 instructors in 14 courses beyond the freshman year.

John H. Meyer became the new dean of men in July after acting as assistant dean of students at Ohio State University.

At Ohio State Meyer was in charge of the administration and development of the 44-chapter fraternity system. His efforts within the dean's office have been directed toward a student development model.

The Inauguration

The forthcoming October inauguration of Dr. B. D. Owens as the University's sixth president will place UT in the national academic spotlight for an entire week and mark another historic moment for Tampa's "Landmark of Learning."

Formal inauguration ceremonies will be held Friday, October 6, at the Curtis Hixon Convention Center, climaxing a week-long program of symposia, featuring nationally known specialists in various fields of education.

NBC television news veteran David Brinkley will open the celebration with a 10:30 a.m. convocation Monday, October 2, in McKay Auditorium, followed by a reception in the University's Fletcher Lounge.

The inauguration is themed around the topic, "Private Higher Education in the 70's: Fulfillment or Failure?", with emphasis on the direction and goals of private higher education in the current decade.

This question will be explored in two daily symposia by experts in the six major divisions of study: humanities, social sciences, fine arts, science, mathematics and education. Included in the discussion groups will be two distinguished college presidents, Msgr. Sebastion Menke, St. Ambrose College, Davenport, Iowa, and Dr. Timothy W. Costello, Adelphi University, Garden City, New Jersey.

"We plan to present a meaningful inauguration in every sense of the world," said Robert B. Gronlund, vice president for development and public relations, at the University, acting inauguration coordinator.

Dr. B. D. Owens will appear for the ceremony with the pomp and dignity traditionally accorded the occasion of an inaugural convocation. He will wear a specially designed robe and carry a new mace.

An inaugural luncheon will follow at 12:15 p.m. in the Gasparilla Room to formally conclude the event, although Dr. Owens will host special quests at Fletcher Lounge that evening.

"I believe in private education," President Owens said, "and I believe this area and this University have tremendous potential and a great future. I look forward to being part of it."

Preparing


More than 29 Hillsborough County agencies engaging in disaster and emergency relief work were involved in planning the one-day Disaster Preparedness Institute held at the University of Tampa in May.

Exercises simulated actual experiences participants might face in handling problems that arise when disaster strikes. They included the collision of a 747 cargo plane and an F4 phantom jet over a heavly populated area: the aftermath of a hurricane, an industrial explosion and the wrecking of a train carrying cargo of chlorine.

Law enforcement, government, military and civilian disaster units took part in the program which was coordinated through the University's Office of Continuing Education and the Red Cross.

The Best Is Yet To Come

"A good year but the best is yet to come" would be a good summary of the fund-raising effort of the University of Tampa for fiscal year 1971-72. Alumni, friends and faculty-staff giving were all up 50% or more. Government grants dropped by almost 50% and accounted for the net dollar increase being limited to 9%. Number of donors increased by 10%.

During the year the University launched a new deferred giving program, a \$200,000 bequest was placed in probate; the new Minaret Society got off to a record-breaking start and the annual Forward Fund went over the top in the large community portion held in the spring. Most of the impact of these programs is not reflected in this year's totals; so the best is yet to come.

The Final Gift Report of the 1971-72 fiscal year, ending June 30, 1972, shows a record high of 1503 donors. Total gift income amounted to \$786,927.96.

Current operations received the largest dollar

total — \$464,342.42. Capital gifts totaled \$164,-529.45; the endowment program received \$91,-601.99 and scholarships and loan gifts reached \$62,155.95.

Foundations contributed the largest single amount — \$175,431.90. Friends were next with \$173,378.24, followed by corporations with \$171,-696.65. Government, both local and federal, contributed \$105,878.00; trustees, fellows and counselors — \$55,968..81; alumni — \$41,314.18; faculty and staff — \$24,719.00; students — \$21,408.68; parents — \$13,852.50 and clubs — \$3,280.00.

The pages that follow list the 1503 donors who have made contributions to the University of Tampa between July 1, 1971 and June 30, 1972. More important, this honor roll of supporters made possible the continued improvement and strengthening of higher education at the University of Tampa. To all who helped make this progress possible and especially to all who gave, a grateful University says "thank you."

While in insurance, Arthur learned the science of estate planning, helping people manage and maintain their personal assets.


