In order to be fair to all candidates involved, the office of attorney general of student government, after conferring with the Deans, has announced that on Monday, May 9, the Student Government will hold a runoff election for the office of Student Body President and President of the Sophomore Class.

After careful examination the election committee came to these conclusions:

 The number of peoples' names checked off in the Registrar's book is 623. This was checked by Paul Jirka, and Robert Klomp, tally was taken 3 times.

2. The number of votes for the President of S.G.A. when

added together was 625.

The number of ballots voided for various reasons, such as voting for the candidate not running, was 8.

There were between 5 and 10 ballots cast just for officers of the Sophomore Class, and no choice made for the President of S.G.A.

Therefore, the number of ballots for the office of President of S.G.A. should tally to be less than the number in the Registrar's book, minus the number of voided ballots, and minus the number that voted for just Sophomore Class officers.

Smoke filled the International Room Wednesday night, as the first on countdown began 808 votes were cast in the first two days of voting. This figure repre-sents over half of our full time students. Approximately the same amount of students voted in last year's election.

From the very beginning Bill Oakerson lead for President and Merry Barr managed to secure the 51% needed to win on the first ballot.

Class officers that were elected are, Paul Jirka who contested Rick Lede; Anita Carbone who also had to secure one more than half the votes, over Tom Cun-ningham and Pete Mack.


